Friends of North Richmond - Over the past fiscal year we have had 1,545 (over 160 volunteers involved in ongoing educational programs) volunteers serving in all programs and events. Through our programs we have had 102 adults empowered through adult education (GED, Jobs for Life, ESL and computer classes), 73 kids enrolled through our after school program, 420 kids in summer kids camp, 26 revitalization projects (includes home repairs and community clean ups), and 128 kids were involved in street church. There were a total of 1,792 people impacted through the entire initiative efforts.

Friends of Uganda - Over the past fiscal year we have served 1,271 people through medical clinics, pastor conferences, mercy ministries, and job creation. We were able to conduct two mission trips allowing 14 people to participate in these activities.

Friends of North Rosenberg - Over the past fiscal year we had 703 (137 volunteers involved in ongoing educational programs) volunteers serving in ongoing programs and events. Through our programs we had 10 adults empowered through adult education (GED, Jobs for Life, ESL and computer) classes. 17 kids enrolled through our after school program, 35 kids in summer kids camp, 44 revitalization projects (includes home repairs and community clean ups), and 450 people impacted through our Thanksgiving event while partnering with 14 different churches. There were a total of 825 people impacted through the entire initiative efforts.
