

Friends of North Richmond - Over the past fiscal year, 1,681 volunteers served in on-going programs and events, and 1,600 volunteers contributed 13,341 hours on 116 revitalization projects and 121 home assessments related to Hurricane Harvey. In our Adult Education programs, we had 93 Adults empowered through classes such as: GED, ESL, Computer Classes, Jobs for Life, and Specialized Workshops. 50 children enrolled in our after-school program, and Mission Week impacted 250 people through 232 volunteers. A total of 2,790 people were impacted through the entire initiative efforts.

4b (Code:) (Expenses \$ 52,861. including grants of \$ 0.) (Revenue \$ 27,452.)

Friends of Uganda - Over the past fiscal year we have served 2,506 people through medical clinics, pastor conferences, mercy ministries, and child development programs. We conducted one medical mission trip, allowing 30 people provide medical care for 1,091 Ugandans.

Friends of North Rosenberg - Over the past fiscal year we had 1,601 volunteers serving in ongoing programs and events. Through our programs we had 14 adults empowered through adult education (GED, Jobs for Life, and computer) classes. 18 children enrolled and participated in our after-school program, and 16 participated in our summer reading program. Volunteers worked 11,982 hours to complete 198 projects related to Hurricane Harvey. A total of 6,584 people were impacted through the entire initiative efforts.
